ORDER ASSESSING FINE

Pursuant to Sections 7-1 of the Residential Mortgage License Act of 1987 (the “Act”)[205 ILCS 635/ 7-1] and Section 1050.2170 of the rules promulgated thereunder (the “Rules”) [38 Ill. Adm. Code 1050.2170], a fine of \$1,000 is imposed against Janie Jakaitis (Registration No. 031.0026909; “Registrant”),

This fine will be imposed for conducting loan origination activities without being duly registered by the Illinois Department of Financial and Professional Regulation Division of Banking. The Department’s records indicate that Registrant was registered as a Loan Originator at Lamb Financial, LLC d/b/a Lamb Financial (MB. 6760662, “Licensee”); however, through an examination of the records produced by Licensee it was found that Registrant before she was granted her registration, in violation of the rules and Act, originated three (3) loans.
