**MORTGAGE LOAN ORIGINATOR LICENSE  
DENIAL ORDER**

The Department of Financial and Professional Regulation, of the State of Illinois, Division of Banking, (hereinafter referred to as the “Department”), pursuant to the Residential Mortgage License Act of 1987, [205 ILCS 635] (the “Act”) and rules promulgated thereunder [38 Ill. Adm. Code 1050] (the “Rules”), hereby issues this ORDER pursuant to the authority provided under Act Section 7-3 (3). The Department has determined after reviewing James Lamson’s records, which include no less than one outstanding tax lien and three outstanding civil judgments, that he is unfit for licensure due to his inability to demonstrate financial responsibility.

NOW IT IS HEREBY ORDERED that the application for Mortgage Loan Originator License of James Lamson is DENIED.
