**MORTGAGE LOAN ORIGINATOR LICENSE**  
**DENIAL ORDER**

The Department of Financial and Professional Regulation, of the State of Illinois, Division of Banking, (hereinafter referred to as the “Department”), pursuant to the Residential Mortgage License Act of 1987, [205 ILCS 635] (the “Act”) and rules promulgated thereunder [38 Ill. Adm. Code 1050] (the “Rules”), hereby issues this ORDER pursuant to the authority provided under Act Section 7-3 (3). The Department has reviewed Barbara Hill’s record of tax liens and poor credit history. Based on this review, the Department finds Barbara Hill to be unfit for licensure due to her inability to demonstrate financial responsibility.

NOW IT IS HEREBY ORDERED that the application for Mortgage Loan Originator License of Barbara Hill is denied.

Code 1050.1570. A hearing shall be held on the administrative decision, by the Department of Financial and Professional Regulation, Division of Banking. Absent a request for a hearing, this Order shall constitute a final administrative Order subject to the Administrative Review Law [735 ILCS 5/3-101 *et seq.*].
