	It was announced that Katy Straub, IDFPR Associate General Counsel is attending this meeting on behalf of Milana Lublin, IDFPR Assistant General Counsel assigned to assist the Task Force.	
Approval of April 11, 2017 Minutes	Dr. Hasan provided suggested edits for clarification to the draft meeting minutes examined by the Task Force. Analysis of Task Force Action

Hard copies of an optometry school course description document were distributed to Task Force Members at the meeting. This information was provided to the Department by Task Force Member Michael Horstman to aid in future curriculum discussions.

The Task Force proceeded to discuss curriculum requirements which would ensure adequate training for optometrists to perform advanced optometric procedures.

Mr. Horstman commented that he believes optometrists today are already receiving the necessary education to provide advanced optometric procedures, but offered for discussion the addition of a hands-on training component to ensure student competency.

The Task Force discussed briefly the possibility of a course similar to Oklahoma's 30 hour course. Mr. Horstman noted that because Oklahoma's courses encompass laser training outside the scope of Illinois legislation, this would effectively make a 30 hour course in Illinois more concentrated on remaining optometric procedures. No agreement was reached on this concept.

Meeting guest Geoffrey Goodfellow, OD, FAAO, Associate Professor and Associate Dean for Academic Assessment and Records at the Illinois College of Optometry, provided extensive information to the Task Force regarding didactic and clinical courses offered at the Illinois College of Optometry, including a breakdown of the structure of each of the four years, on a quarterly basis. References were made to the course description

document distributed at the beginning of the meeting.

Goodfellow described Dr. internship requirements in various patient population and treatment settings. Each student must obtain a at least 70 total internship credits, comprised of 10 hours each in the pediatrics, advanced areas of optometry, low vision, cornea contact lens, and elective, and 20 hours in primary care. procedures performed by students are overseen and evaluated by trained clinicians. Students progress as they demonstrate proficiency. Dr. Goodfellow estimated that students attending the Illinois College of Optometry see approximately 1500-1600 patients during their four-year curriculum.

Dr. Hasan inquired into the qualifications of faculty that teach surgery and injection courses to optometry students. Dr. Goodfellow responded that the courses are taught by board-certified ophthalmologists. Students practice the following types of injections on one another (but not on actual patients): subconjunctival, intramuscular, and intravenous.

Dr. Goodfellow provided information regarding the various optometry residency programs which are available for students to pursue, but optional. Dr. Goodfellow offered to remain available to answer any additional questions the Task Force may have.

Dr. Hasan and Dr. Albanis asked a number of questions relating to the curriculum at the Illinois College of Optometry, as well as residency and externship programs, especially the

	clinical experience received by students.
