Dr. Hasan thanked Richard Paul for compiling these materials and explained that the information contained therein is relevant to the development of curricular standards for optometrists to perform advanced optometric procedures.

Dr. Hasan indicated that at the next regularly scheduled meeting date of August 22, 2017, the statewide organization representing ophthalmology plans to provide the Task Force with its recommended minimum educational requirements for a licensed optometrist to obtain a certification to perform advanced optometric procedures.
